Dear Applicant:

This letter is in reference to: (1) the above-captioned minor change "one step" application, as last amended on November 8, 2004, to change channel, effective radiated power, antenna height, and location; (2) the March 5, 2004 Informal Objection filed by Calvary Chapel of Big Bear; (3) the March 25, 2004 Informal Objection filed by LBI Radio License Corp.; (4) the October 4, 2004 Informal Objection filed by Ministerio Palabra Viva; and (5) all other related pleadings. For the reasons set forth herein, we deny the informal objections, and grant the application.

On March 5, 2004, Calvary Chapel of Big Bear ("Calvary"), the licensee of KWBB-LP, Big Bear Lake, California, filed an informal objection stating that KXRS's application is in violation of 47 C.F.R. § 73.211. However, an engineering review reveals that the application, proposing a Class A facility with 6.0 kilowatts effective radiated power (ERP) at 85 meters antenna height above average terrain, complies with 47 C.F.R. § 73.211. Therefore, Calvary's March 5, 2004 Informal Objection will be denied.

On March 25, 2004, LBI Radio License Corp. ("LBI"), the licensee of KBUE(FM), Long Beach, California, filed an informal objection stating that KXRS's application is in violation of 47 C.F.R. § 73.315.¹ Specifically, LBI argues that KXRS's proposed Longley-Rice signal level predictions indicate that signal levels of at least 70 dBu would only cover 72.9% of the area and 67.4% of the population of Hemet, well below the 80% coverage to achieve substantial compliance with § 73.315(a). We forwarded the objection to our propagation expert at the Office of Engineering and Technology ("OET") to perform an independent study. OET concluded that there is no major terrain obstruction and the application demonstrates compliance with 47 C.F.R. § 73.315. Therefore, LBI's March 25, 2004 Informal Objection will be denied.

On October 4, 2004, Ministerio Palabra Viva ("MPV"), licensee of KGIC-LP, Corona, California, filed the Informal Objection stating that KXRS's "one step" application is moving closer to MPV's frequency. However, MPV fails to provide any substantive ground for objection of the application. Furthermore, the engineering review reveals that KXRS's application demonstrates compliance with all necessary rules. Therefore, MPV's October 4, 2004 Informal Objection will be denied.

¹ The March 24, 2004 Reply to Lazer Broadcasting's Response filed by Calvary Chapel of Big Bear also claims that KXRS violates this rule.

In light of the above, (1) the Informal Objection filed by Calvary on March 5, 2004; (2) the Informal Objection filed by LBI on March 25, 2004; (3) the Informal Objection filed by MPV on October 4, 2004; and (3) all other related pleadings ARE HEREBY DENIED. In addition, Application File No. BPH-20040205AAK, as last amended on November 8, 2004, IS HEREBY GRANTED. The authorization is enclosed.
