Dear Mr. Wagner,

I am in receipt of your attached July 2, 2015 letter with reference to KEVA(AM), Evanston, WY FCC (Facility ID No. 20028 / FCC File No. BR-20130604ACN).

Please be advised that I no longer represent Sagebrush Broadcasting Company, Inc. and further did not represent it for the filing of the referenced licensed renewal application.

In May of 2013, prior to the filing of the license renewal application, I was contacted by George L. Arnold, Attorney at Law, (307) 789.7887 voice / (307) 789.2451 fax / GArnold@arnoldlawoffices.com. Mr. Arnold asked if I could assist with FCC matters regarding KEVA. I informed Mr. Arnold that absent satisfactory arrangements being made for my representation, I was unable to.

Subsequent to the filing of the KEVA license renewal application and the license renewal applications for commonly-owned KQYW, KTHE and KDNO, I noted that the licensee had filed the applications listing my name as contact representative.

On June 5, 2013, I sent an email to Mr. Arnold noting that the applications were filed erroneously listing my name as contact representative. Mr. Arnold responded that the applications would be amended (I, in fact, forwarded Mr. Arnold detailed instructions on how to change the name of the contact representative in CDBS). Apparently, the change to the KEVA application was never made.

Please advise if I need to file a formal notification with the FCC Secretary to remove my name from the KEVA license renewal application as contact representative. Thank you.
