## Dear Ms. Kreisman:

Thank you for the opportunity to file a petition for Eligible Entity Status in accordance with DA-679 and to explain why we believe our station is eligible for full Class A station protection and should be added to the DA-679 appendix listing eligible stations for the auction.

We believe we can show that WMJN-LP meets all FCC Class A station requirements for the reasons indicated below.

WMJN-LP was licensed as a Class A station on July 19<sup>th</sup>, 2001(copy of the license is enclosed). We are operating and have been operating as a Class A station. In addition, the correspondence folder for our station on the FCC site shows no formal action has ever been taken to revoke this status, nor have we purposely acted to terminate our class A status.

Footnote 8 of Public Notice DA 15-679, released June 9<sup>th</sup>, 2015 states, "Regardless of whether a station is listed in the appendix, the Incentive auction R&O prohibits a station from being protected in the re-packing process or participating in the reverse auction if its license has expired, is subject to a revocation order(collectively a license validity proceeding"), or is for a Class A station that is subject to a downgrade order, provided that the license validity proceeding or Class A downgrade order has become final and non-reviewable by a date prior to commencement of the auction that will be specified in the procedures PN.

By these criteria we respectfully assert that we should not be prohibited from the auction. Our station's license is not expired, has not and is not subject to a revocation order (collectively "license validity proceeding," and has never received a downgrade order from Class A status.

Therefore we meet all the criteria of DA 15-679 and respectfully request that our station be designated an eligible facility for the auction, placed on the list and enabled to submit FCC Form 2100, Schedule 381, and be allowed to participate in the auction.

Like many small stations we add value to our communities with local programming not provided by larger stations and do this with limited resources. Last year we invested over \$50,000 to go digital to better serve our area. We believe it would be in the best interest of our community if we are allowed to stay on the air to serve them, and we respectfully ask that you approve this request so we can do so.
