Dear Mr. Do:

This is in reference to the request filed on June 10, 2015. Intelli requests an extension of the STA granted on September 17, 2014, to operate station KAZA(AM) with temporary facilities due to loss of the licensed site.¹ In support of the request, Intelli states that it continues to search for a new site in order to file an FCC Form 301 application to propose a new facility.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

We note that the previous STA expired on March 16, 2015, yet Intelli did not file a request for extension of the last STA until June 10, 2015. Our review indicates that the circumstances presented warrant grant of STA in order to provide for service to the public, and that the requested STA facilities are the same as were previously authorized. However, in light of the lapse of time between the expiration of the prior STA and the filing of the instant request, it will be considered as a request for a new STA; and therefore the authority granted herein does not cover the period between March 16,

2015, and June 10, 2015, and is without prejudice as to whatever action the Commission's Enforcement Bureau staff may take with respect to operation of Station KAZA(AM) during the foregoing period.

In addition, the request did not include a statement to verify that Intelli submitted the results of measurements before September 27, 2014, to demonstrate that sufficient duplexing equipment was installed and adjusted to reduce all spurious emissions below the levels specified in 47 CFR Section 73.44(b), along with a copy of a firm agreement between stations KAZA(AM) and KZSJ(AM) clearly fixing the responsibility of each with regard to the installation and maintenance of such equipment. As a result, this information must be submitted now in a separate paper filing in triplicate with the office of the Secretary within the next ten days (by July 19, 2015) to the attention of Jerry Manarchuck, Audio Division, Media Bureau, to avoid cancellation of this STA.


Accordingly, the request for extension of STA is GRANTED and station KAZA(AM) may continue to operate with the following facilities:

Geographic coordinates	36° 57' 49" N, 121° 29' 22" W (NAD 1927)
Frequency	1290 KHz
Hours of operation	Unlimited
Operating power	1.25 kW (day), 0.02 kW (night)
Antenna type	Existing tower of KZSJ(AM), ID#30906
Antenna efficiency	307 mV/m

It will be necessary to further reduce power or cease operation if complaints of interference are received. Intelli must notify the Commission when licensed operation is restored after an FCC Form 301 and 302 application have been filed and granted. Intelli must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. We anticipate that Intelli will have their consulting engineering firm (Hatfield and Dawson) prepare and file an acceptable FCC Form 301 application before the expiration date shown below in order to show that substantial progress has been made.

This authority expires on **January 9, 2016**.
