This letter is to update you on the efforts of Reier Broadcasting Company, Inc. ("Reier"), licensee of the above-referenced stations and of FM translators K240CO, Livingston, MT

(Facility ID No. 76695), K265AS, Livingston, MT (Facility ID No. 11248) and K288ES, Big Sky, MT (Facility ID No. 76696), to institute payment plans for its past due Regulatory Fees.

Since receipt of your letter, dated June 18, 2015, informing it that it must pay, or arrange for payment of, its Regulatory Fee debts or risk dismissal of its pending renewal applications, Reier has worked diligently to arrange payment for these debts, and has specific proposals pending with two of the three entities handling these debts. However, Reier will need additional time to collect and produce detailed financial information required to complete its payment arrangements. Reier respectfully requests that any dismissal of its above-captioned renewal applications be stayed while Reier continues the process of setting up its payment plans.

Reier's Regulatory Fee debts are held by three entities: the FCC, the Department of the Treasury, and Pioneer Credit Recovery (acting as an agent of the Department of the Treasury). Below, we discuss the status of each debt in turn.

For those debts still with the Commission, Reier submitted a payment plan proposal to the Office of Managing Director – Financial Operations, asking for a plan with a payment of \$400 a month. The Commission staff acknowledged receipt of the request and assigned it a tracking number (16008). The OMD is processing payment plan requests in the order they were received, so Reier is unable to say when its request will be processed.


For the Department of the Treasury, Reier set up a 36-month payment plan for these debts. The monthly payment is \$1,446. The payments under this plan will begin on August 1. The Treasury Department, however, is requiring Reier to complete the detailed Commercial Debtor Financial Statement form. Completion of that form will require Reier to gather documentation not immediately available to it.

With respect to Pioneer Credit Recovery, before it will set up a payment plan, it is requiring Reier to submit a completed Commercial Debtor Financial Statement form. As noted above, that form requires Reier to gather extensive financial information. Reier has not yet been able to gather that information, but is endeavoring to do so. Thus, we do not yet know the amount of the payments or when they will begin, and will not know this information until after the disclosures form is completed, submitted and processed.

Reier will continue working diligently to complete the process of arranging for payment plans for its outstanding Regulatory Fee debts and urges the Commission to grant it additional time to do so.
