Dear Mr. Lui:

This is in reference to the request filed on July 21, 2015. WBL requests a second extension of the STA granted on July 2, 2014, to operate from the construction permit site (BP-20131223AF1) due to redevelopment of the licensed site facility.¹ In support of its STA request, WBL states that all final steps should be completed within the next 60 days in order to allow for the filing of an FCC Form 302 application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and station WZHF(AM) may continue to operate with the following facilities:


¹ WZHF(AM) is licensed for DA operation on 1390 kHz with 5 kW (unlimited), and the construction permit BP-20131223AF1 authorizes a change in site and patterns.

In addition, WBL may operate the station pursuant to Section 73.1615 and the terms and conditions of BP-20131223AFI with the substantially adjusted daytime and nighttime patterns authorized by the permit. It will be necessary to further reduce power or cease operation if complaints of interference are received. WBL must file a one page letter to the attention of supervisory engineer Son Nguyen to certify resumption of licensed operations after an FCC Form 302 application has been granted to cover the construction permit.² WBL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47CFR 1.1310. We anticipate that an acceptable FCC Form 302 application will be filed and granted before the expiration date shown below.

This authority expires on **February 17, 2016**.
