#### **OPPOSITION TO PETITION TO REVOKE LICENSE**

## **AND CONSTRUCTION PERMIT**

Comes now, Omni Broadcasting, LLC ("Omni"), by its counsel, respectfully opposes the Petition to Revoke License and Construction Permit ("Petition") filed in this matter by Miracle Radio Inc., ("Miracle"). As shall be demonstrated below, this Petition should be dismissed.

1. Miracle presents two arguments as to why Omni's License and Permit for W246BN should be revoked. First, Miracle states that Omni had "not obtained permission in any form to rebroadcast WPNN" and because Omni lacked this permission, it misrepresented itself to the FCC. This first argument is supported by a Declaration from Scott Schroeder. Therein, Mr. Schroeder declares "MCI has never given its consent to the rebroadcast of Station WPNN over W246BN either orally or in writing". The second argument is that the broadcast of WKTE-FM is illegal as it violated Section

74.1232(d) of the rules pertaining to extending coverage contour of WTKE-FM beyond rule limits. Each of these arguments is incorrect.

- 2. To begin, Omni was granted authority by Gerald D. ("Don") Schroeder to rebroadcast WPNN. Attached hereto as Exhibit 1, please find an e-mail dated February 6, 2013 from Mr. Schroeder to Omni's Manager, Ron Hale. Mr. Schroeder signed the e-mail as President of Miracle Radio, Inc. The evidence is quite clear that Omni had authority to rebroadcast WPNN. This nullifies the Declaration of Scott Schroeder. Omni could argue that Mr. Schroeder's Declaration is nothing but a misrepresentation of the facts to the FCC and an attempt to discredit a competitor in its market. However, Omni prefers to believe that this is simply a miscommunication between Don Schroeder and his son, Scott Schroeder, and that Scott Schroeder did not know that Omni had properly obtained permission from his father. Had this been known, Omni believes their pleading would not have been submitted.
- 3. The argument by Miracle of the violation of Section 74.1234 (d) is likewise misplaced and must be rejected. Omni's W246BN is not rebroadcasting WTKE-FM, rather it is rebroadcasting WDWR (AM), Pensacola, Florida, AM HD Channel 2. That channel is providing sports programing for WDWR (AM) and is then rebroadcast by W246BN. Attached hereto as Exhibit 2 is a permission letter from Divine Word Catholic Radio granting authority to rebroadcast its HD programming.

4. For the reasons set forth above, the Commission must DISMISS the Petition
