WITHDRAWAL OF REMAINING INFORMAL OBJECTIONS

At this time, REC is satisfied with negotiations that are taking place between the applicants with the objective of reaching a universal settlement with all remaining tentative selectees in MX Group #27 including those that REC has interest in.

With that in mind and in order to reach a common goal of assuring that Channel 268 is most efficiently used throughout the community by as many of the applicants as possible, REC feels that it is in the best interest to remove the final barriers that are preventing an agreement from moving forward.

REC still strongly holds the belief that the issues, especially where it comes to potential collusion and other negotiations prior to the window to aggregate points still exists. This issue would probably be better addressed in rulemaking in order to prevent this from happening again in a future LPFM filing window. REC also feels that issues still exist with other applicants as explained in previous filings but we will leave these issues to the discretion of the Commission to resolve.

Based on these points, REC is requesting that <u>all</u> of our *Informal Objections* against the above captioned applicants be <u>withdrawn</u>. REC has not received any consideration in connection with this withdrawal and it is being done at our own free will.

REC will continue to work with our applicants and with the entire MX Group #27 to assure that an agreement is made that assures that as many Southern California residents will be able to experience the diversity of programming these stations have to offer.
