

**Motion for Extension of Time**

Sun Broadcasting Inc. (“Sun”) requests that the time for responding to the September 23, 2015, Petition to Deny (“Petition”) filed by Beasley Media Group, LLC and Renda Broadcasting Corporation (collectively “Petitioners”) be extended through October 19, 2015. In support of this request, Sun submits that researching a response to Petitioners’ allegations of de facto transfer of control of Fort Myers Broadcasting Company’s radio and television stations is a time intensive undertaking requiring Sun and its counsel to spend significant time reviewing evidentiary facts. Sun’s management and its counsel have other obligations that have delayed their efforts to complete a coordinated review of relevant facts within the response time allotted by Rule 1.45. The requested extension should be sufficient to complete this review and prepare a response to concerns raised by Petitioners. Pursuant to Rule 1.4(c), Petitioners, Educational

Media Foundation and responsible Commission staff have been orally notified that this motion is being filed.


