Dear Counsel:

This is in reference to the request filed March 13, 2007, on behalf of Citicasters Licenses, LP ("Citicasters"). Citicasters requests extension of special temporary authority ("STA") to operate Station KIIS-FM with a hybrid digital signal,¹ pursuant to the *First Report and Order* in MM Docket No. 99-325 ("*Report and Order*").² Citicasters proposes operation with separate analog and digital antennas, pursuant to the Public Notice issued March 17, 2004 ("Public Notice").³ Our review indicates that the proposed operation complies with the requirements of the Public Notice.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KIIS-FM may operate with a hybrid digital signal as defined in the *Report and Order*.⁴ The digital signal will be transmitted via licensed auxiliary antenna BXLH-20040402ACR. The digital transmitter

power output will be 0.229 kilowatt. The analog transmitter power output will be 7.41 kilowatts. Citicasters must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines; *See* 47 CFR § 1.1310. Pursuant to 47 CFR Section 73.1635(b), this authority may be modified or cancelled by the Commission without notice or right to hearing. Citicasters must post a copy of this authority with the station license. Any subsequent modification of the licensed analog facilities will require a modification of this authority.

This authority expires on **September 14, 2007**.
