To whom it may concern:

My name is Geovanna Martinez I met Nick Vicente many years before he entered the world of radio. Nick was a promoter and bought commercials from a local radio station called Radio Fiesta 1600am. In which he still owes money for publicity that aired and never paid the gentlemen that rented the radio station in that time was Sergio Armenta.

On September 5th 2007 I had returned from my vacations and was invited to work Nick Vicente and his team. I resigned from the radio station I was working at 1550am because Nick Vicente promised me a better salary and bonuses. I have been in the radio industry since 1997 in the following departments: Live Announcer, Traffic, Production, Programming and some Promotions.

I started as a live announcer, with time I started assisting with traffic and programming because his help wouldn't last. They would say he didn't pay them but I would receive my pay because I would bring him sales. I worked for Nick Vicente for 4 years, until this day he still owes me money. He never paid by check because he can't have a personal account under his name since he owes so much money. In the second year that I was working for Nick Vicente he rented a new station 92.1fm in Utah County. It didn't last more than 6 months because of nonpayment. Nick hid equipment in the ceiling panels but was served with paperwork from his business partner and they confiscated everything.

Nick opened and close offices throughout the city approximately 5 times. Nick even took us to work where he had the transmitter because nobody wanted to rent him any offices or spaces. Nick never paid rent, utilities or rights to the music we downloaded to program on the radio such as SESAC. When SESAC, ASCAP or BMI would call he would tell me to answer and hang up, he said the music is free and I shouldn't have to pay for anything free. Nick forced us to use YouTube to be able to program new music. When I started having financial problems I asked him to pay me what he owed me. He would give me enough money to make a payment on my bills. Nick owed me so much money that I didn't want to leave so he would pay me completely. I lost my house and family. They kept telling me to just walk away from the money that he owed me but I didn't walk to walk away. I never wanted to lose hope that there was something better for me.

I would always have to deny that he was at the office, all the money coming in to the radio was spent on liquor, women, and a lot of drugs.

I started to earn your earn his trust he considered me his right hand. He never had a payroll department because he never had any money to pay anyone and if he did pay it was in cash.

I stayed without work because he said that he was going to close everything. Nick left one computer inside where he had the transmitter. The next 6 months I worked at a beauty salon that is my profession but don't practice it anymore. Nick would always call me and tell me there was something big coming and that he was gathering the money he owed me to pay me. In March he called me to tell me that he almost had all the money he owed me and that he was going to be the owner of a FM/AM radio and that he really need me because I knew so much in the industry. I believed him so I accepted to

return to the radio, he started building his personnel I was only to be a live announcer, he brought a person for programming Mario Hidalgo and to do traffic. With Mario they started bringing dance after dance and as always Nick Vicente stopped paying so he left. When Mario left in November 2011 Nick asked me to also do traffic it was a new system so I had to learn from nothing to work it, until this day I'm still learning how to use it.

We stayed in the same building that 104.7fm MI PREFERIDA had started. In the month of December I noticed that Nick was still the same miserable, money hungry liar. He started having all personnel due live mentions of his dances and adding more commercials and music of the bands that he was bringing. We were prohibited to speak to Scott Matthews he would always tell us that he was only the engineer of the radio. In that month we had a radio thon for a shelter and that is when I finally figured out that Nick was not the owner and that he had lied about being the owner of 104.7fm that the true owners of the radio were Maverick and the CEO was Scott Matthews.

When I started to talk to Scott I told him that Nick was forcing us to program publicity without contracts. Nick wouldn't bring any cash to the radio for the publicity that he had us program in the system he had us enter the commercials as PSA so nobody would suspect anything out of the ordinary. I told Scott that we did not want lose our jobs, the sales reps couldn't come to the radio. All the contracts were under Nicks name none under the sales rep that he had working for him.

When they started the investigation the system had too many commercials for the amount of money that was coming into the radio. Nick threatened me that if I opened my mouth about anything he was going to have me fired from the radio because he was the owner of the radio. I didn't care anymore and told Scott everything with details, Nick lost all access to the radio and we finally started to have a normal work atmosphere. One day one of his accomplices tried contacting me he kept insisting and insisting for me to answer him so I finally did. He went into detail how and what Nick had him doing and using the radio as his backup plan. All the bad things finally caught up to him and he got arrested and was deported back to Mexico. He told me that I needed to be very careful because Nick had put a hit on Scott, another employee and me. He said I know you don't want to believe me but I'm sending you the conversation that Nick and I had to take all 3 of you out thru Facebook. When I heard the conversation I couldn't believe it and went to the police for help. They contacted Daniel and wanted complete details of everything.

I am sending this letter because Nick Vicente is not a business man he's a crook, thief and liar. My life has completely changed I live in fear thinking that someday he is going to show up to harm me or my family all because I said the truth. Nick doesn't deserve to have people believe he is the owner of such a growing industry. He owes so many people, people that believed him in good faith that one day he would repay them. Nick deserves to be in jail he is a crook, the same way I lost everything there's people that lost the same there homes, cars, and business but most important they lost the emotional stability of having life savings taken from them. I hope you take this letter into consideration and don't let any more people get hurt or harmed by Nick Vicente.

Since LA RAZA 107.1fm went on air out of the 11 people that started the radio with him there are only 2 employees still working him. The reason I know is because they came to our radio station asking for employment since Nick again didn't pay any of his employees.
