Request for Tolling of Construction Term

Dear Ms. Dortch

This letter is written on behalf of Southwest FM Broadcasting Co., Inc. ("Southwest FM"), licensee of Station KAHM, Prescott (and permittee to change community of license to Spring Valley), Arizona, and is with regard to the Commission's grant of its application for a minor change in the station's facilities (BPH-20100813BHN, granted January 11, 2013 (hereafter "KAHM Grant")).

On February 4, 2013, Kemp Communications, Inc. ("Kemp") filed a Petition for Reconsideration of the KAHM Grant (as well as a Motion for Stay of the effectiveness of the KAHM Grant). See enclosure.

The KAHM Grant provides that the authorized period for construction terminates on January 11, 2016. Section 73.3598(b)(2) of the Commission's rules provides that, upon timely written request, the authorized period for construction specified in an FCC construction permit will be tolled in the event the grant is the subject of "administrative or judicial review (i.e., petitions for reconsideration ...").

As the KAHM Grant is now the subject of Kemp's Petition for Reconsideration, Southwest FM hereby requests that the period for construction specified in the KAHM

Grant be tolled until such time as the KAHM Grant is no longer the subject of administrative or judicial review.

Southwest FM will keep the Commission informed of future developments which bear upon the tolling of the construction period specified in the KAHM Grant.
