Dear Sir or Madam:

Pursuant to Section 73.1680(b)(1), Beasley Media Group, LLC, licensee of radio broadcast Station WNCT(AM), Greenville, North Carolina, Facility ID No. 57841 (the "Station"), provides notification that the Station is operating with an emergency antenna, and hereby requests Special Temporary Authority to continue operation with the emergency antenna.

During the early morning of September 4, 2015, the WNCT(AM) studio and transmitter facilities suffered a major fire. On the evening of September 8, 2015, the Station recommenced program service to the public at 25% of nominal licensed power (2.5 KW) using the non-directional element of the Station's directional antenna system.

The required certification pursuant to the Anti-Drug Abuse Act of 1988 is attached hereto.

This STA request is being filed on paper because the CDBS database is currently nonfunctional due to the Commission's upgrade of its computer systems.


