Dear Ms Dortch:

On behalf of Calvary Radio Network, Inc. ("CRN"), licensee of the thirteen (13) noncommercial educational FM stations listed in the attachment to this letter, this is to advise you that copies of the public inspection files for the twelve (12) CRN stations subject to waivers of the main studio rule will no longer be maintained in their communities of license.

All of the listed stations have been granted waivers of Section 73.1125(a) of the rules pertaining to main studio location. In each waiver request, CRN made a commitment to make a copy of the station's public file available in the community of license. However, because CRN does not maintain local offices in these distant communities, it has had few, if any, requests from members of the public to view its local public inspection files in those communities. Moreover, the FCC now views the maintenance of local files as optional for "waivered" NCE stations. Accordingly, effective immediately, CRN will no longer maintain public files in the communities of license of the listed stations. It will, however, continue to maintain complete public files at each station's main studio at 150 West Lincolnway, Valparaiso, Indiana, the main
