Dear Mr. Davis:

This is in reference to the request filed on November 6, 2015. CCL requests a third extension of the STA granted on April 24, 2014, pursuant to Section 73.1635 of the Commission's Rules to operate with parameters at variance and/or reduced power while maintaining monitor points within license limits due to sampling system repairs.<sup>1</sup> In support of the request, CCL states that over the past five months it designed and ordered new phasing system equipment, and additional time is needed to complete renovations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for STA IS HEREBY GRANTED and station WREC(AM) may continue to operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. However in accordance with Section 73.68(e)(2), immediately prior to modification or replacement of components of the sampling system, and after a



verification that all monitoring point values and operating parameters are within the limits or tolerances specified in the rules, the following indications must be recorded for each radiation pattern: Final plate current and plate voltage, common point current, antenna monitor phase and current indications, and the field strength at each monitoring point. Subsequent to these modifications or changes the procedure must be repeated. In addition, in accordance with Section 73.68(e)(3) if monitoring point field strengths or antenna monitor parameters exceed allowable limits following the replacement or modification of that portion of the sampling system above the base of the towers, a partial proof of performance shall be executed in accordance with Section 73.154. The partial proof shall be accompanied by common point impedance measurements made in accordance with Section 73.54. It will be necessary to further reduce power or cease operation if complaints of interference are received. CCL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. CCL must file an FCC Form 302 application to update all operating parameters after all remaining work has been completed.

This authority expires on **June 4, 2016**.
