Special Temporary Authorization

Dear Counsel:

This is in reference to the request filed May 4, 2006, on behalf of CSN International (CSN). CSN requests further extension of the special temporary authority (STA) originally granted on May 25, 2001, to operate Station WAJC (formerly WXJC) from a site other than the licensed site.¹

In support of the request, CSN states that when it purchased WAJC it was forced to change transmitting sites; that its application for minor change to relocate the station's transmitter, BPED-20010412AAS, was denied by the Commission on June 25, 2001, for failure to provide the required community coverage. CSN states that the only way it can bring WAJC into compliance with the community coverage rules is to file a major change application to change the community of license, and that there currently is a freeze on the filing of such applications. Finally, CSN states that, until the freeze is lifted, WAJC must either continue STA operations or go dark.²

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;

¹ Station WAJC is licensed for operation on Channel 213A (90.5 MHz) with effective radiated power (ERP) of 3.8 kilowatts (H&V), and antenna height above average terrain (HAAT) of 30 meters.

² We note that, subsequent to the filing of CSN's request, the Commission has changed its rules regarding community of license changes for broadcast stations. See *Revision of Procedures Governing Amendments to FM Table of Allotments and Changes of Community of License in the Radio Broadcast Services, Report and Order*, MB Docket No. 05-210, FCC 06-163, November 29, 2006. The new rules became effective on January 19, 2007. However, a revised Form FCC 340 has not yet been released, which has prevented the filing of applications pursuant to the new rules by noncommercial, educational FM stations such as WAJC.

- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WAJC may continue to operate with the following facilities:

Antenna height:	
above ground:	46 meters
above mean sea level:	143 meters

CSN must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **September 21, 2007**.
