Dear Mr. Do:

This is in reference to the request filed on December 14, 2015. Intelli requests a second extension of the STA granted on September 17, 2014, to operate with temporary facilities using the currently licensed non-directional antenna system of AM station KZSJ (ID# 30096), due to loss of the licensed KAZA(AM) transmitter site. In support of the request, Intelli states that it continues to search for a new transmitter site in order to file the required FCC Form 301 application to propose a permanent facility.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Mr. Dennis Kelly was advised via a Commission staff e-mail on January 6, 2016, that his client station KZSJ(AM) must file a letter with the Commission before January 15, 2016, to request that the last license be reissued, and to certify no changes to the operating parameters. In addition, Intelli may have to consider filing an FCC Form 301 application using the existing KZSJ transmitter

site (if unable to locate a new site within the next six months). Otherwise Intelli must submit all other new steps taken during this STA period to show that substantial progress has been made towards restoration of licensed operations.

Accordingly, the request for extension of STA is GRANTED and station KAZA(AM) may continue to operate with the following facilities:

It will be necessary to further reduce power or cease operation if complaints of interference are received. Intelli must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on July 11, 2016.
