Living Proof, Inc. ("Living Proof") filed an assignment application with the Federal Communications Commission on January 26, 2016, seeking to assign Construction Permit BNPFT-20130826AEE for unbuilt FM Translator Station K244EW at Palmdale, California (hereinafter the "Construction Permit") to Kiertron, Inc. ("Kiertron") (BAPFT-20160126ADS). Kiertron subsequently filed a minor change modification application for K244EW on January 29, 2016 (BMPFT-20160129AFG). The purpose of the modification is to allow Kiertron to rebroadcast KBRT (AM), Costa Mesa, California.

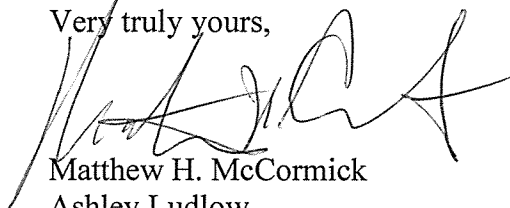
The Construction Permit currently is scheduled to expire on April 1, 2017. Living Proof accordingly requests that the Construction Permit be tolled pursuant to Footnote 36 of the FCC's October 23, 2015 "AM Revitalization" Order, FCC 15-142, for one year and 64 days from the later of the grant of the above-referenced assignment application or the above-referenced modification application.
