He's Alive, Inc. ("He's Alive") filed an assignment application with the Federal Communications Commission on January 28, 2016, seeking to assign Construction Permit BNPFT-20130823ADF for unbuilt FM Translator Station W235CC at Wheeling, West Virginia (hereinafter the "Construction Permit") to AJG Corporation ("AJG") (BAPFT-20160128BBN). AJG subsequently filed a minor change modification application for W235CC on January 29, 2016 (BMPFT-20160129ALB), which was amended on February 3, 2016. The purpose of the modification is to allow AJG to rebroadcast WCLG (AM), Morgantown, West Virginia. Upon grant of the modification application, AJG will build the modified translator promptly.


The Construction Permit currently is scheduled to expire on December 6, 2016. He's Alive accordingly requests that the Construction Permit be tolled pursuant to Footnote 36 of the FCC's October 23, 2015 "AM Revitalization" Order, FCC 15-142, for 313 days from the later of the grant of the above-referenced assignment application or the above-referenced modification application.
