Family Stations, Inc. ("Family") and Pennsylvania Media Associates, Inc. ("PMA") filed an assignment application with the Federal Communications Commission ("FCC") on January 28, 2016, seeking to assign Construction Permit BNPFT-20130328ARM for unbuilt FM Translator Station W240CO (now W268CN) at Charlotte, Michigan (hereinafter the "Construction Permit") from Family to PMA (BAPFT-20160128BDR). PMA subsequently filed a "250 mile" minor change modification application for W240CO on January 29, 2016 (BMPFT-20160129AXN), which was granted March 3, 2016. The purpose of the modification is to allow PMA to rebroadcast WDTK (AM), Detroit, Michigan.

The Construction Permit is currently scheduled to expire on May 1, 2016. Family and PMA accordingly request that the Construction Permit be tolled pursuant to Footnote 36 of the
