Change in Main Station/Satellite Station Designation WWRN (FM), Rockport, MA (Facility Id. No. 176844)

Light of Life Ministries, Inc.

Dear Ms. Dortch:

Light of Life Ministries, Inc. ("Light of Life"), licensee of Noncommercial Educational (NCE) Station WWRN(FM), Rockport, Massachusetts (the "Station"), respectfully requests that the Commission change the designation of the main station to which the Station operates as a satellite. On February 4, 2011, the Commission granted to Light of Life the authority to operate the Station as a satellite of Station WWWA(FM), Winslow, Maine, pursuant to a waiver of Section 73.1125 of the Commission's Rules.

Light of Life requests the Station's existing main studio waiver be modified to designate the Station as a "satellite" of Light of Life's NCE Station WMDR(AM), Augusta, Maine, Facility Id. No. 37469. The Station and WWWA are co-owned, share the same main studio location, and the same personnel. As with the 2011 Waiver, the operation of the Station as a satellite of WMDR(AM) will facilitate the efficient and economical operation of the two stations in question. The cost savings that would be gained by operating the Station from the Augusta studio are particularly significant in these difficult economic times.

Light of Life personnel will consult on at least a quarterly basis with an advisory board from Rockport in order to ascertain the community's needs and interests. A toll free telephone number already is in place that can be used by the Station's listeners to reach the staff and management at Light of Life. A complete public file will continue to be maintained at the Rockport Town Hall at 34 Broadway, Rockport, Massachusetts, and at the WMDR studio in Augusta.

Therefore, Light of Life respectfully requests the Commission change the designation of Station WWRN(FM) from operating as a satellite of Station WWWA(FM), Winslow, Maine, to operating as a satellite of Station WMDR(AM), Augusta, Maine. Light of Life certifies that neither it nor any party to the application is subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. Section 862.
