Dear Mr. Price:

This is in reference to the request filed on March 9, 2016. TMTL requests an extension of the STA originally granted on granted on December 4, 2012, and last modified on March 26, 2015, to to operate KOSY(AM) with parameters at variance and/or reduced power from its licensed technical parameters due to multiple problems.¹ In support of the request, TMTL states that additional time will be needed to prepare and submit an FCC Form 302 application to update all operating parameters.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED and station KOSY(AM) may continue to operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. TMTL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of

¹ KOSY(AM) is licensed for operation on 790 kHz with 1 kW (ND) day and 0.5 kW (DA) night.

the Commission's exposure guidelines. *See* 47 CFR § 1.1310. We anticipate that TMTL will file an FCC Form 301 to correct site coordinates (if more than three seconds change) along with an FCC Form 302 application with a nighttime method of moments or partial proof in the near future in order to move forward towards resuming licensed operations.

This authority expires on **September 29, 2016**.
