Supplement to Response to Informal Objection

Dear Ms. Dortch:

Eternal Word Television Network, Inc. ("EWTN"), by its attorney, hereby respectfully supplements its October 15, 2008 response to an Informal Objection to the referenced application dated December 12, 2007 (but not received by the FCC mailroom until December 18) that had been filed by Richard Snyder.

In its October 15 response, EWTN noted that all of the allegations contained in the Informal Objection were wholly speculative and unsupported, yet refuted each of them (that is, to the extent possible in light of their abstract and often irrelevant nature). One of the allegations was that: "NOT ONE OF THESE APPLICATIONS [unidentified, but presumably including the subject EWTN application] HAS APPLIED TO THE TOWER OWNER FOR PERMISSION TO LOCATE ON THE TOWER" [all capital letters in original]. EWTN responded that while it could not speak for others of "these applications" (whoever they might be, as none was identified), "EWTN obtained a written confirmation of site availability from the owner of its proposed tower prior to filing the subject application." FCC staff has requested substantiation of this aspect of EWTN's response.

Submitted herewith is an email chain that documents that on October 16, 2007 (*i.e.*: two days prior to filing EWTN's subject application), permission was obtained to locate anywhere from the 363 foot level to the 443 foot level on the tower. In fact, EWTN's application specifies a radiation center 120 meters (*i.e.*: 393.7 feet) above ground (*see* BNPED-20071018AJN at section VII, item 8). Consequently, it is clear that prior to filing its application EWTN had obtained reasonable written assurance that its proposed site would be available.
