Dear Mr. Davis:

This is in reference to the request filed on May 27, 2016. CCL requests a further extension of the STA granted on June 29, 2006, to operate Station WSYR with parameters at variance due to all required repairs done over the past ten years.¹ In support of the request, CCL states that it plans to complete all work and then file the required FCC Form 302 application to update all operating parameters in order to show that substantial progress has been made.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED and CCL may continue to operate WSYR(AM) with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. CCL must use whatever means

are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. Although we anticipate that CCL should be able to file the FCC Form 302 application before the expiration date shown below, a final request for an extension of this STA must be filed on that date if that application remains pending.

This authority expires on **December 24 2016**.
