Dear Mr. Martin:

This is in reference to the request filed on June 2, 2016. SEB requests a second extension of the STA grantee on May 13, 2015, to operate station KWWJ(AM) with parameters at variance to allow time to file an FCC Form 301 application to correct parameter errors on the last license.<sup>1</sup> In support of the request, SEB states that its consulting engineer is preparing to file the required FCC Form 301 application to correct the height and coordinate errors, which must be followed by an FCC Form 302 application filing to obtain a new license.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and station KWWJ(AM) may continue to operate with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to



further reduce power or cease operation if complaints of interference are received. SEB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **December 24, 2016**.
