Dear Ms. Cherry:

This is in reference to the request filed on June 21, 2016. JTC requests a further extension of the STA granted on February 10, 2015, to operate WPUL(AM) with temporary facilities at an alternate site due to problems at the licensed site.¹ In support of the request, JTC requests additional time to file an FCC Form 301 application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

JTC will need to retain a private consulting engineer to assist in preparing and filing the required FCC Form 301 application by perhaps using an existing station tower site (or by proposing construction of a new tower elsewhere). Any future request must include a statement

to clarify why JTC has been unable to resume operations at the licensed site, an estimate of the efficiency of the STA tower, and what new steps have been taken to show that substantial progress has been made.


Accordingly, the request for extension of STA is GRANTED, and JTC may continue to operate station WPUL(AM) with the following facilities:

Geographic coordinates	29° 12' 07" N, 81° 01'29" W (NAD 1927)
Frequency	1590 KHz
Hours of operation	Unlimited
Operating power	0.25 kW day, 0.32 kW night
Antenna type	Existing 24 meter tower
Antenna efficiency	Unknown

It will be necessary to further reduce power or cease operation if complaints of interference are received. JTC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **January 26, 2017**.
