This is in reference to: 1) the request for extension of STA filed August 3, 2005, on behalf of former licensee Great Southern Broadcasting Company, Inc. ("GSB"); and 2) your letter dated January 12, 2006, filed on behalf of Bott Communications, Inc. ("BCI"), which notifies the Commission that BCI is now the party in interest with respect to the subject STA. GSB requested further extension of the Special Temporary Authority (STA) originally granted on August 14, 1990², and modified on February 12, 1998³, to duplicate the programming of Station WCRT (formerly WAMB) on an FM channel for the purpose of restoring service lost due to interference from a co-channel Cuban station operating in excess of its notified power.

Our review indicates that, on February 24, 2005, the Commission authorized construction of two Low-Power FM ("LPFM") Stations; WZLU-LP, Nashville, Tennessee, File No. BNPL-20010614ACL, and a new LPFM station at Brentwood, Tennessee, File No. BNPL-20010615AWS.⁴ Our records do not indicate that either LPFM station has completed construction and commenced operation; however, in the event that this should occur, the LPFM station would receive impermissible interference from BCI's STA operation. BCI recognizes this

issue, and requests extension of STA with a condition relative to the LPFM stations. Extension of STA will be granted as requested, with a condition.

Accordingly, in light of the above, the request for extension of Special Temporary Authority IS HEREBY GRANTED, with conditions as discussed above. The call sign of the FM booster station IS HEREBY MODIFIED to WCRT-FM1. BCI may continue to operate Station WCRT-FM1 for the purpose of duplicating the programming of Station WCRT, nighttime hours only, with the following facilities:

Transmitter site:	Tower #1 of licensed WCRT array
Geographic coordinates (NAD 1927):	36° 09' 49" N, 86° 42' 56" W (same as WCRT)
Channel:	254 (98.7 MHz)
Effective radiated power:	0.075 kilowatt (Max-DA, H&V)
Antenna height	
Above ground:	110 meters (360')
Above mean sea level:	241 meters
Above average terrain:	83 meters

BCI must take whatever action is necessary to prevent exposure of workers or the public to radio frequency fields in excess of the Commission's exposure limits. See 47 CFR Section 1.1307.

Upon commencement of operation and/or the filing of an application for license by LPFM Station WZLU-LP, or upon commencement of operation and/or the filing of an application for license by LPFM Station 20010615AWS, this authority will terminate, and operation must cease immediately.

Unless terminated earlier as described above, this authority expires on **November 8, 2007**.
