Request for Waiver of 47 C.F.R. § 73.3598 FM Translator Station K268DF, Lincoln, NE (formerly K286CF, Shenandoah, IA) Facility Identification Number: 141262

Dear Ms. Dortch:

Alpha 3E Licensee LLC ("Alpha"), the proposed assignee of FM translator station K268DF, Lincoln, Nebraska (formerly K286CF, Shenandoah, Iowa), hereby requests a waiver (47 CFR §1.3 and §73.3598) of the construction deadline for the K268DF construction permit pursuant to Note 36 in the *First Report and Order*, *Further Notice of Proposed Rule Making and Notice of Inquiry* in MB Docket No. 13-249, *Revitalization of the AM Radio Service*, 30 FCC Rcd 12145 (2015). Note 36 states that waivers of the Auction 83 FM translator permit deadlines are "presumptively in the public interest for applicants participating in one of the modification windows, provided that the AM station licensee proposing to use the FM translator for rebroadcasting its AM station commits to prompt FM translator station construction and initiation of broadcast operations."

The original K268DF construction permit (call sign K286CF) was granted as a result of the Auction 83 window filings (see File Nos. BNPFT-20030314BRT, BNPFT-20130830AQO), and the permit is scheduled to expire on January 15, 2017. The holder of the construction permit is KMA Broadcasting, L.P. ("KMA"). KMA is selling the permit to Alpha, and an application is pending (File No. BAPFT-20160902AAF) for consent to the assignment of the K268DF construction permit from KMA to Alpha. KMA has filed, and the Commission has granted, a 250 mile window application (File No. BMPFT-20160729ANT) to relocate the translator in order to rebroadcast Alpha-licensed AM station KLMS, Lincoln, Nebraska. In the attached certification, Alpha commits to promptly constructing and initiating operation of the translator once it closes its acquisition of the construction permit so that KLMS can be rebroadcast as contemplated in the AM Revitalization Order.

Accordingly, Alpha respectfully requests a waiver of 47 CFR §1.3 and §73.3598 to extend the construction deadline of the permit for K268DF until six months after Alpha consummates its acquisition of the construction permit.
