Request for Modification of Waiver of 47 C.F.R. § 73.1125 (Main Studio Rule)

Dear Mr. Alonzo Williams:

The staff has under consideration an September 13, 2016, letter request (the "Request"), fired on behalf of Family Life Broadcasting, Inc. ("FLB") for modification of the "satellite" waiver of the Commission's Main Studio Rule, Section 73.1125 of the Commission's Rules (the "Rules")¹ previously granted for the Stations listed in an Appendix to this letter. In the Request, FLB seeks merely to change the "Parent" station that originates the programming for the satellite stations and communities from KFLT-FM, Tucson, Arizona, to KFLT(AM), Tucson, Arizona. FLB also would designate the KFLT(AM) studio facility at 7355 N. Oracle Road, Tucson, Arizona, as the satellite stations' main studio location.² FLB indicates that it will continue to fulfill its local service obligations to the satellite communities by: (1) maintaining an auxiliary study at each of the stations' transmitter sites capable of originating local programming responsive to local community needs; (2) continue to conduct quarterly ascertainment surveys of local leaders in the satellite communities to determine problems, interests, and needs there, the results of which will be reflected in FLB's news and public affairs programming: (3) retaining a toll-free telephone number from the satellite communities to the KFLT(AM) studio, as required by Section 73.1125(d) of the Rules; and (3) making reasonable accommodations to listeners wishing to examine any of the stations' Tucson public inspection files.

Because FLB proposes to maintain in effect the representations and commitments upon which the Commission granted waivers of Section 73.1125 for each of the listed stations and proposes to change only the "parent" station for its satellite operation, we are persuaded that FLB will continue meet its local service obligations and, thus, that grant of the requested waiver modification is consistent with the public interest. We remind FLB, however, of the requirement that it maintain a public file for each of the listed stations at the main studio of the "parent" station, KFLT(AM), Tucson, Arizona. It must also make reasonable accommodation for listeners wishing to examine the file's contents.² We further remind FLB that, notwithstanding the grant of the waiver modification requested here, the public file for KFLT(AM) must contain the quarterly issues and programs list for each of the listed stations, as required by Section 73.3527(e)(8) of the Rules.

Accordingly, the September 23, 2016, request for modification of the waiver of 73.1125 of the Commission's Rules for each of the stations listed in the Appendix to this letter, IS HEREBY GRANTED.
