Request for Modification of Main Studio Waivers

Dear Ms. Dortch:

Family Life Broadcasting, Inc. and its affiliates Family Life Broadcasting System, a Michigan nonprofit corporation and Family Life Broadcasting System, a New Mexico nonprofit corporation (together "FLB") the respective licensees of the referenced noncommercial stations, respectfully request a modification of each of the stations' waiver of 47 C.F.R. Section 73.1125, the Commission's main studio rule to allow the stations, each currently a "satellite" station of Family Life Broadcasting, Inc. licensed KFLT-FM (Facility ID 81952) Tucson, Arizona, to become a "satellite" station of Family Life Broadcasting System licensed noncommercial station KFLT (AM), (Facility ID 20649) Tucson, Arizona.

To ensure The Stations fulfill their local service obligations to their local communities, FLB will continue to:

- (1) Maintain an auxiliary studio at each station's respective transmitter site. Such an auxiliary studio will be capable of originating local programming that is responsive to local community needs.
- (2) Continue to conduct quarterly ascertainment surveys of local community leaders and other residents to determine the concerns, problems and needs of the listeners in each licensed community that will be covered in FLB's news and public affairs programming.
- (3) Maintain a toll-free telephone number from each community of license to KFLT(AM) in Tucson, Arizona as required by §73.1125(e) of the rules, and
- (4) Maintain a public inspection file in Tucson, Arizona as required by Section 73.3527 of the Commission rules.

The only change requested is to switch the primary stations from one FLB noncommercial Tucson station to the other FLB noncommercial Tucson station.
