This is exactly what I was looking for. Thank you so much for the quick response! So while the STA application (File No. BSTA-20050831ADY) was granted on the same day this was filed, the flash cut application (File No. BPTVL-20050711AAB) was ultimately dismissed on 10/4/2005. KVTU-LP (formerly KSPP-LP) now operates on channel 3. Under legal status for the flash cut application this Petition to Deny is listed as dismissed. Looks like we just forgot to do the same under legal status for the STA. Does ABC have any objection to us switching the status of this Petition under the STA application to dismissed? I'm guessing you already considered this matter closed. I am happy to put together a letter officially dismissing the Petition, or is this e-mail exchange sufficient? Just let me know.
