Special Temporary Authorization

Dear Counsel:

This is in reference to the request filed July 11, 2007, on behalf of Greater Philadelphia Radio, Inc. ("GPR"). GPR requests special temporary authority ("STA") to operate Station WJJZ with temporary facilities.¹ In support of the request, GPR states that Station WBZH recently relocated to a new transmitter site and that its newly authorized auxiliary facility is not ready for operation due to delays in delivery of necessary equipment. GPR states that necessary maintenance on the tower lighting at the new site will require it to shut down operations. GPR requests STA for operation from its formerly licensed site, only for the brief times necessary to facilitate the tower maintenance.

Our review indicates that, although the two transmitter sites are separated by nearly 40 kilometers, Station WJJZ continues to serve the same community of Burlington, and that no other station is likely to receive interference from the proposed STA operation. Moreover, GPR is in the process of constructing auxiliary facilities for the new site, but has been prevented from completing that construction due to causes beyond its control.

Accordingly, the request for STA IS HEREBY GRANTED. Station WJJZ may operate with its formerly licensed facilities², only as necessary to facilitate the tower maintenance:

Effective radiated power:	50 kW (H); 48 kW (V) (Max-DA)

¹ WJJZ is licensed for operation on Channel 248B (97.5 MHz) with effective radiated power of 26 kilowatts (H&V) and antenna height above average terrain of 208 meters.

above mean sea level: 163 meters
Above average terrain: 131 meters

GPR must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **October 23, 2007**. No extension of this authority is contemplated.
