**REPLY TO OPPOSITION TO PETITION FOR RECONSIDERATION**

Edgewater Broadcasting, Inc., (“Petitioner”) by its counsel respectfully submits its reply to the Opposition to Petition for Reconsideration (“Opposition”) filed by Evans Broadcast Company, Inc. (“Evans”). Petitioner has no reason to doubt the facts presented in the Opposition and upon reviewing the Opposition, is certain that the mistakes in Evans’ initial license application were nothing more than a miscommunication between Evans and his consulting engineer.

At the time the Petition was filed, Petitioner was only aware that K236CN was not constructed at the location specified in the license application. Petitioner was able to hear the station when monitoring from the licensed site, but did not see transmission equipment anywhere near the site. Based on these circumstances, Petitioner did further research and uncovered the other discrepancies contained in the technical portion of the license application. There was no way Petitioner could have known that a miscommunication in the location of the site by 2 minutes resulted in the faulty license application.

The emails between Evans and his consulting engineer, plus the lease identifying the actual site where Evans intended to build and the declarations of the participants has convinced

Petition that the filing of the erroneous license application was an honest mistake and nothing more.

Based on the corrective measures Evans has taken (taking the station silent and amending the license application to correct the errors), Petitioner believes the issues it raised in the Petition have been address and respectfully withdraws its Petition.


