**Re: Request for Waiver of Construction Permit Deadline  
Construction Permit for FM Translator W249CU  
Westchester, MA/Philadelphia, PA  
FCC Facility ID No. 138663  
File Nos. BNPFT-20130822AAV, BMPFT-20160927ADK**

Dear Ms. Dortch:

This request is being submitted on behalf of AMFM Radio Licenses, LLC (“AMFM”) pursuant to Section 1.3 of the Commission’s rules and in accordance with footnote 36 of the *AM Revitalization First Report and Order*,<sup>1</sup> and the Modification Window Procedures Public Notice.<sup>2</sup> That footnote states that a waiver of an Auction 83 FM translator construction deadline is presumptively in the public interest for applicants participating in one of the modification windows, provided that the AM station licensee proposing to use the FM translator for rebroadcasting its AM station commits to prompt FM translator station construction and initiation of broadcast operations.

AMFM is the holder of an Auction 83 construction permit for a new FM translator station W249CU, Westchester, Massachusetts, FCC Facility ID No. 138663 (the “Station”), File No. BNPFT-20130822AAV (the “Construction Permit”). An application to modify the Construction Permit was filed during a “250-mile modification window” established by the Commission’s *AM Revitalization Order*.<sup>3</sup> The Modification Application, which is currently pending, specifies

AM station WDAS, Philadelphia, Pennsylvania (which is licensed to AMFM) as the primary station to be rebroadcast by the Station.

AMFM hereby requests a waiver of the construction deadline of the Construction Permit until the latest date permitted by the Commission.<sup>4</sup> AMFM hereby commits to prompt construction of the Station and initiation of service. A waiver of the construction deadline here will promote the public interest by facilitating cross-service broadcasting opportunities for an AM station and allowing an AM licensee to realize service improvements quickly, thus avoiding the delay and administrative burdens of re-auctioning the spectrum.
