Dear Mr. Wagner:

This is in reference to the request filed on January 6, 2017. URL requests a further extension of the STA granted on August 6, 2010, to continue operating from an alternate site pending further action on BP-20170106ABO to propose a new permanent site facility.¹ In support of the request, URL stated that it no longer plans to sell the station, and instead plans to build and license the facility specified in BP-20170106ABO.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and URL may

continue to operate with the following facilities:

It will be necessary to reduce power or cease operation if complaints of interference are received. URL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on July 25, 2017.
