STATEMENT IN SUPPORT OF PETITION FOR RECONSIDERATION

Bowers Broadcasting Corporation ("Bowers"), by its attorneys, hereby files this statement in support of the Petition for Reconsideration filed by AJG Corporation ("AJG"). That Petition sought reconsideration of the denial of the extension of time to consummate the abovereferenced assignment of license application. Bowers, as the proposed assignee, continues to stand ready to close the sale of its stations to AJG. Bowers continues to be owned by Linda Bowers, who plans to retire after the sale of the stations that her late-husband operated for many years. If the Petition for Reconsideration is denied, that will require the re-filing of the assignment application, which initially took approximately 18 months for the FCC to approve.
