Dear Counsel:

This is in reference to the request filed September 22, 2006, on behalf of Lazer Licenses, LLC ("LLL"). LLL requests extension of the special temporary authority ("STA") granted on June 22, 2006, to operate Station KOXR with reduced power.¹ In support of the request, LLL states that its equipment is failing to switch to the nighttime pattern at the required times and that time is required for evaluation and repairs; that a new switch has been ordered and that additional time is required for delivery and installation.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

¹ KOXR is licensed for operation on 910 kHz with 5 kilowatts daytime and 1 kilowatt nighttime, employing different directional antenna patterns during daytime and nighttime hours (DA-2-U).

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KOXR may operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. Operation with a nondirectional antenna and reduced power not to exceed 1.25 kilowatt daytime and 0.25 kilowatt nighttime also is authorized, only as necessary to facilitate the repair work. It will be necessary to further reduce power and/or cease operation if complaints of interference are received. LLL must notify the Commission when licensed operation is restored.² LLL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **November 7, 2007**.
