INTERFERENCE COMPLAINT

Nelson Rodriguez (“Rodriguez”), licensee of full power FM station WJES, Maysville, Georgia (Facility ID #198772), by counsel and in accord with §74.1203 of the Commission’s rules, hereby submits this complaint of actual interference to the reception of WJES caused by signals transmitted by co-channel FM translator station W265AV, Woodstock, Georgia (Facility ID #28332), licensed to Immanuel Broadcasting Network, Inc. (“IBN”).

Section 74.1203 of the Commission’s rules states that

An authorized FM translator . . . will not be permitted to continue to operate if it causes any actual interference to: . . . The direct reception by the public of the off-the-air signals of any authorized broadcast station. . . . Interference will be considered to occur whenever reception of a regularly used signal is impaired by the signals radiated by the FM translator . . . regardless of the quality of such reception, the strength of the signal so used, or the channel on which the protected signal is transmitted.


Submitted herewith are statements from 37 members of the public who aver that their ability to use the WJES signal is hampered by interference from W265AV. There is clear and abundant evidence of actual interference.

Section 74.1203(b) further provides that “. . . [O]peration of the offending . . . station shall be suspended and shall not be resumed until the interference has been eliminated.”

Consistent with the provisions of the Commission’s rules, Rodriguez demands that IBN take steps immediately to cease interfering with the WJES signal, including suspension of the operation of W254AV if necessary.
