- The permittee/licensee must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency radiation in excess of FCC guidelines.
 - 2. The relative field strength of neither the measured horizontally nor vertically polarized radiation component / shall exceed at any azimuth the value indicated on the composite radiation pattern authorized by construction permit BPED-930915IC.

A relative field strength of 1.0 on the composite radiation pattern herein authorized corresponds to the following effective radiated power:

17.0 kilowatts.

Principal minima and their associated field strength limits:

160 degrees True: 2.05 kilowatts 340 degrees True: 16.1 kilowatts.

- 3. That Family Life have at least one resident from Spencer, NY on its Advisory Board.
- 4. That Family Life attempt to develop local programming and open a production studio in Spencer, NY.
