Dear Mr. Artim:

This is in reference to the request filed February 2, 2007, on behalf of Radio Disney Group, LLC ("RDG"). RDG requests extension of the special temporary authority ("STA") granted August 3, 2006, to operate Station WDYZ with emergency antenna facilities pursuant to Section 73.1680.¹ In support of the request, RDG states that the replacement part has been installed and that it is waiting on scheduling of its consulting engineer for the necessary adjustment and proof measurements.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that Construction Permit BP-20070420ABR, to augment the nighttime pattern, was granted on September 6, 2007, and that License Application BZ-20070413AHC is pending before the Commission. Thus, the licensee has made substantial progress toward restoring licensed operation, and extension of STA is warranted to allow time for processing the

¹ WDYZ is licensed for operation on 990 kHz with 50 kilowatts daytime and 14 kilowatts nighttime, employing different directional antenna patterns daytime and nighttime (DA-2-U).

license application. In light of the foregoing, the STA will be modified to specify operation with parameters at variance and/or reduced power while maintaining monitor points within licensed limits.

Accordingly, the request for STA IS HEREBY GRANTED. Station WDYZ may continue to operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. RDG must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **December 13, 2007**.
