Antenna is to be face-mounted as a common unit on an existing self-supporting, steel tower also used as the TV antenna supporting tower for Station KSL-TV. OVERALL

Neither the license nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This license is subject to the right of use or control by the Government of the United States conferred by section 606 of the Communications Act of 1934.
