Subject to the provisions of the Communications Act of 1934, as amended, treaties, and Commission Rules, and further subject to conditions set forth in this license, the LICENSEE

DENNING BROADCASTING GROUP, INC.

is hereby authorized to use and operate the radio transmitting apparatus hereinafter described for the purpose of broadcasting for term ending 3 a.m. Local Time: August 1, 1980

The licensee shall use and operate said apparatus only in accordance with the following terms:

This license is subject to the right of use or control by the Government of the United States conferred by section 606 of the Communications Act of 1934.
