ORDER TO SHOW CAUSE

This will permit you to operate at night beginning on the date set forth below with a nominal power of 67.0 watts. (Instructions for calculating the actual operating power are enclosed.)

IF YOU OBJECT TO THIS MODIFICATION you may, pursuant to SECTION 1.87 of the Commission's Rules, request that a hearing be held on the proposed modification or file a written statement in opposition to the modification proposed in this Order to Show Cause. In such case, the Commission will conclude that Station WAGS does not wish to have nighttime operation, and the station license will not be so modified. Instead, it will retain its current daytime—only authorization.
