New Inspiration Broadcasting Company, Inc. ("NIBC") filed a minor modification application with the Federal Communications Commission ("FCC") on October 5, 2016, seeking to modify the facilities of FM Translator Station K260CG, Mohave Valley, AZ (now K241CT, Oceanside, CA) (FCC Facility ID No. 157948), which was conditionally granted on May 8, 2017 (FCC File No. BMPFT-20161005ABS) (the "Construction Permit"), prior to the receipt of Mexican concurrence.

The Construction Permit currently is scheduled to expire on November 8, 2017. NIBC accordingly requests tolling of the Construction Permit expiration date, until the pending Mexican concurrence is obtained.

NIBC certifies that it is not subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. Section 862.
