A vertical, guyed, series-excited, steel radiator of non-uniform cross-section 48.77m (55.6°) in height (50.29m Overall) with an STL side-mounted. The bottom 40 feet of the tower is triangular cross-section, 45cm (18") across on a side, and the top 120 feet of the tower is triangular cross-section, 31.25cm (12.5") on a side. Theoretical efficiency: 282.9 mV/m/kW at 1 km. Ground system consists of 120 equally-spaced, buried, copper wire radials, each 79m (260') long, buried 25cm (10") deep.
