Dear Mr. Price:

This is in reference to the request filed on May 2, 2017. TMTL requests a further extension of the STA granted on December 4, 2012, to continue operation with night DA parameters at variance pending the filing of the required FCC Form 302 application to update all operating parameters.¹ In support of the request, TMTL states the site coordinates must be corrected and the ground system repaired, therefore additional time is needed to determine if an FCC Form 301 application will be filed first to modify the nighttime antenna system (instead of simply making all required repairs based upon the last license).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED, and TMTL may continue to operate with night DA parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power

or cease operation if complaints of interference are received. TMTL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. TMTL must file the required FCC Form 301 application to modify the antenna system if any changes are desired that require a construction permit. Otherwise the required FCC Form 302 application must be filed to update all operating parameters (after all repairs have been completed).

This authority expires on **December 5, 2017**.
