Friends of Christian Radio, Inc. ("FCR") and Caron Broadcasting, Inc. ("CBI") filed an assignment application with the Federal Communications Commission ("FCC") on July 29, 2016, seeking to assign the construction permit for unbuilt FM Translator Station W263CS (now W262CY), Cleveland, Ohio (Facility ID No. 145205) from FCR to CBI (File No. BAPFT-20160729ANP), which was granted September 9, 2016, and consummated on October 20, 2016.

CBI filed a contingent "250 Mile Modification" application for W263CS on July 29, 2016 (File No. BMPFT-20160729ANY), which was granted on September 9, 2016. The purpose of the modification is to allow CBI to rebroadcast WHKW (AM), Cleveland, Ohio, on the translator.

The W263CS/W262CY Construction Permit is currently scheduled to expire on January 10, 2017. CBI accordingly requests a waiver of the construction deadline for the Construction Permit pursuant to Footnote 36 of the FCC's October 23, 2015 "AM Revitalization" Order, FCC 15-142, for six months from the consummation of the assignment.
