Dear Mr. Fuss:

This letter is in reference to the pending minor modification and license renewal applications of Delta Radio Network, LLC, for Stations WIQQ(FM), Leland; WNIX(AM) and WIBT(FM), Greenville; and WNLA(AM) and WDTL(FM), Indianola, Mississippi.

We cannot process the referenced applications and have been holding the four listed license renewal applications since February of 2012, the WIQQ(FM) modification application since March of 2015, and the WDTL(FM) modification application since May of 2016, pursuant to the Commission's "red light" rules, which prohibit the staff from granting an application when an applicant is delinquent on

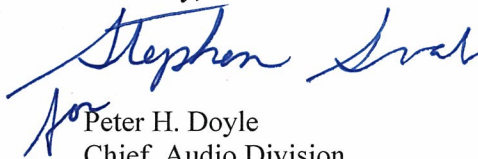

debts owed to the Commission.³ We believe that it is not in the public interest to retain unprocessable applications for extended periods of time, particularly when the extended delay is the result of the inaction of an applicant to correct a debt delinquency.⁴

Accordingly, we are providing Delta Radio Network, LLC, a period of 30 days from the date of this letter to pay or arrange for payment of the delinquent debt with the Commission's Office of Managing Director.⁵

Failure to have the "red light" status removed within that time period will result in the dismissal of the referenced applications pursuant to Sections 1.1910(b)(3) and 73.3568(a)(1) of the FCC's rules.⁶
