If interference cannot be eliminated to the satisfaction of WXPB(FM) by the application of suitable techniques, operation of WPEB(FM) shall be suspended and shall not be resumed until the interference has been eliminated.
  
- 3 Grant of this license application is conditioned on the continuous operation of the licensed facility for the twelve-month period following grant. The failure of the facility to so operate will result in the rescission of this grant, dismissal of the license application and the forfeiture of the associated construction permit pursuant to 47 C.F.R. § 73.3598(e) unless the licensee rebuts the presumption that the authorized facilities were temporarily constructed.
