INTERFERENCE COMPLAINT

Calvary Chapel Lebanon, the licensee of LPFM station WLEB-LP, Lebanon, Pennsylvania (hereafter "WLEB-LP" or "93.1 FM") by its attorneys, pursuant to Section 74.1203(a)(3) and Section 74.1203(b) of the Commission's rules, hereby seeks with regard to the licensed facilities of W226CC, Lancaster, Pennsylvania licensed to Capstar TX, LLC the immediate remediation of the interference being caused by the operation of the W226CC facilities to at least <u>56</u> WLEB-LP radio listeners listening to the regularly-used signal of cochannel WLEB-LP. In support, the following is submitted:

Interference is Being Caused to At Least 56 WLEB-LP Listeners by W226CC Operations

As stated in the attached Declaration of Thomas Keller, WLEB-LP President,
WLEB-LP is an existing radio station broadcasting with FCC licensed facilities pursuant to FCC
File No. BLL-20031021ADJ as renewed in FCC File No. BRL-20140227AAW. WLEB-LP has
been broadcasting with such facilities since October, of 2003.

2. On June 15, 2017, Mr. Keller began receiving calls from existing WLEB-LP listeners complaining about interference to the WLEB-LP signal in locations where previously

the WLEB-LP signal was regularly received without issue. After investigating the source of the interference, Mr. Keller determined that the interference was coming from the W226CC operations of Capstar TX, LLC.

3. Attached to Mr. Keller's Declaration are interference complaints from 56 WLEB-LP listeners, each titled a "Listener Declaration." Each Listener Declaration states the area in which interference to the WLEB-LP signal is being experienced, gives identifying information, and states that other than being a regular listener to WLEB-LP which is known to listeners as "93.1 FM", he or she does not have any other connection to WLEB-LP.

Capstar TX, LLC Has an Obligation to Remediate Interference

4. The Commission's rules restrict the operation of FM translator stations to strictly a secondary basis. Section 74.1203(a)(3) of the Commission's rules states that an FM translator station will not be permitted to continue to operate if it causes any actual radio signal interference to the direct reception by the public of the off-the-air signals of any authorized broadcast station. The prohibition extends to existing LPFM stations as Section 74.1203(a)(3) protects "the direct reception by the public of the off-the-air signals of <u>any</u> authorized broadcast station ..." (emphasis added). WLEB-LP is an authorized broadcast station.

5. The existence of listener complaints indicating that their regularly received signal is being impaired by the signal of an FM translator is sufficient to show actual interference. Section 74.1203(b) of the Commission's rules states that if the interference cannot be properly eliminated by the application of suitable techniques, the operation of the offending FM translator station shall be suspended and shall not be resumed until the interference has been eliminated.

6. Based on the above, it is respectfully requested that the Commission issue a letter to Capstar Texas, LLC requiring that it take all appropriate actions to remediate all 56 listener interference complaints, as required by Section 74.1203. Should Capstar Texas, LLC fail to resolve all of the 56 interference complaints, W226CC should be required to suspend operations.

CONCLUSION

7. Capstar Texas, LLC is interfering with the regular listening patterns of at least 56 WLEB-LP listeners in violation of Section 74.1203(a)(3) of the Commission's rules. Capstar Texas, LLC should immediately be required to remediate each listener interference complaint.
